\*Organizing and signing contracts with supplementary insurances in order to quickly collect income and contracts related to VIP departments as well as international patient department (IPD),

\* Monitoring the systems connected to SEPAS and monitoring the updated submission of files and verification of the data sent by the centers, especially the credit rows.

\* Issuing and communicating the notified guidelines and strategic purchasing standards and following up on selected topics for implementation,

\* Solving the problems of hospitals with insurance organizations and interacting to improve the situation,

\* Investigating the amount and causes of deficits and implementing necessary interventions to reduce insurance deficits and means to follow up on insurance claims,

\* Carrying out periodic visits in order to comply with the procedures issued by the relevant ministry and providing, feedback to the units.

As part of my efforts to empower managers and employees in governmental hospitals in Ilam province, I developed a specialized training workshop on Health Economics, covering 20

different topics. This initiative aimed to equip healthcare professionals with the necessary skills and knowledge to effectively manage the financial aspects of hospital operations. I sent a copy of the content of the program to Insurance, Medical Tariffs and Health Standards Department of Iranian Ministry of Health and Medical Education.

## **Experiences**

 Associate Professor: Department of Public Health, Ilam University of Medical Sciences, since 03/02/2017

In this position my main responsibilities were teaching and doing research projects. Besides that, simultaneously I engaged in several executive position in different deputies on Ilam Medical Universities. The details of my main responsibilities and also teaching and research resume are as follows:

#### 2- Social Health Determinants Department:

In this role, I engaged in establishing and implementing several different activities:

The first one was working as the head of Ilam Province Health Master Plan to develop a master plan for Ilam province in collaboration with the Iran National Health Research Institute. This plan aimed to improve the public health of the region by building strong partnerships with nonhealth governmental organizations to develop and implement joint projects aimed at addressing health issues in the province. We applied social determinants of health model to prepare this plan. A very strict and scientific approach was followed to run the project. After team building and holding several orientation sessions, the main health problems of the province were identified by interviewing the key stakeholders including Public House, health officials, the general managers of the main related organizations such as health insurance schemes, municipality, hospitals etc. Using the best-worst method and inviting more than 50 experts, the main health issues (8 goals addressing all aspects of health including mental health, physical health and environmental health) were finalized. For each health issues, a separate team with all relevant stakeholders was built and after introducing the program, we identified the best projects to tackle each health issue. It should be mentioned that all necessary measures were applied to publicize the program as much as possible. For example, in the Health and Food Security Committee" in Provincial Government where the governor and the head of all governmental organizations were attendant, we presented the program. This committee served as a platform to discuss health issues, assess the impact of decisions on public health, and take necessary actions to address health problems. It was so effective to gain the support and commitment of the governor and other organizations. We could define joint projects with more than 25 governmental organizations which committed to work together towards improving the social and economic factors contributing to health problems. This project received recognition from the governor of Ilam province. Although I quit this position after finalizing and communicating the plan by the governor, it is still being implemented and is the main project for encouraging intersectoral collaboration within the region.

My passion for social determinants of health (SDH) led me to further my knowledge in this area through extensive reading and participation in non-governmental activities. In addition, I as a member of the social deputy team, spearheaded the establishment of community-based organizations (CBOs) to promote public participation in health promotion initiatives. These CBOs were run by local volunteers and played a crucial role in improving community health.

## 3- Clinical Governance and Accreditation (from 16-11-2011 to 20-1-2014)

As the head of Clinical Governance and Accreditation Department in Reza hospital in Tehran, Iran, my responsibilities included establishing and implementing high standards for patient safety indicators, self-development plans, strategic planning, and patient rights. My extensive experience with international accreditation standards for hospitals allowed me to effectively implement these standards within our organization.

#### **Ongoing qualitative research projects:**

- From the May 2024, I have been working on a qualitative study about the experiences of infertile couples from surrogacy in Kurdish ethnicities in Iran using grounded theory (Corbin and Strauss 2015) and phenomenological approaches. For the purpose of the study, all stages of grounded theory including Micro analysis-open coding, Developing concepts (properties and dimensions), Analyzing data for context, Bringing process in the analysis and Integrating Categories (Core variable) and tools explained by Corbin 2015 were followed. To do so, I did 16 interviews with infertile women who had used surrogacy to have a baby and two health personnel working in Infertility Treatment Centers in Kermanshah province, located in the west of Iran. Interviews were analyzed using MAXQDA20 and the theory has been finalized. I am working on the paper now.
- Simultaneously, I am working on two other phenomenological studies titled "Discovering the lived experience of people with gender identity disorder: trough descriptive phenomenology" and " Explaining the experiences of employees working in women's counseling centers in providing services to sex workers: a phenomenological study".
